2. Summary of the Project

On September 19, 2009, 18 members of the Tree Lovers of MD were joined by 4 Master Gardeners and 16 members of Boy Scout Troop #531 to plant 20 trees in the Oaktown Community Park. The purpose of the planting was to introduce plant diversity into the park and further encourage new wildlife habitat. The entire town was previously planted with nothing but oaks. The Master Gardeners designed a planting plan and taught the other volunteers how to correctly plant the trees during a three-hour hands-on workshop. The planting was covered by the local newspaper and an article describing the event was printed in the community section of the Sunday Edition. See enclosed newspaper article.

3. Monitoring and Maintenance

For the next three years, the Tree Lovers plan to water the trees and keep a 2-inch layer of mulch around the base of the trees. The Boy Scouts plan to move the location of their annual camping event in the park to the Oaktown Community Park beginning this year.
