APPLICATION TO TEMPORARILY TRANSFER COMMERCIAL TIDAL FISH LICENSE**

**TEMPORARY TRANSFER:** The transferor (person transferring license) and transferee (person receiving the license) must complete, sign and present in person with photo ID, this application along with applicable fees to **temporarily** transfer a commercial tidal fish license. The physical presence of either the transferor or transferee may be waived provided their signature has been notarized on the application. A completed Commercial Tidal Fish Application (DNR C-1) signed by the transferee must accompany this application.

**License or Authorization**

Authorizations may be transferred up to two times per license year. A \$50 transfer fee (per authorization), \$215 Harvester Registration (Fishing Guides are exempt) and Seafood Marketing Surcharge is due at time of transfer.

- A Fishing Guide license may not be transferred between a resident/non-resident.
- A copy of the transferee's current USCG Captains license must be provided for all Fishing Guide transfers.
- An Unlimited Tidal Fish License cannot be broken into individual authorizations for a temporary transfer, unless otherwise permanently converted by the transferor.
- The transferee will report catch under the transferor's license number while under the temporarily transferred license/authorization.
