Application for Shellfish Aquaculture Lease – Lee R. Beauchamp & Matthew R. Holloway #546, Worcester County

The Secretary of Maryland Department of Natural Resources (DNR), pursuant to Natural Resources Article, §4-11A-09(g), Annotated Code of Maryland, is giving notice of an application for a shellfish aquaculture water column lease by Lee R. Beauchamp and Matthew R. Holloway in Chincoteague Bay, Worcester County, Maryland, located approximately 9,000 feet northwest of the Scotts Landing portion of the Assateague Island National Seashore in the vicinity of the Pirate Islands, and 4,850 feet east of red channel marker "26". The area applied for contains 38.3 acres more or less and is enclosed by a line beginning at corner 1, at or near Lat. 38° 6' 42.1" N., Long. 75° 14' 35.7" W., then running 293° 50' (True), approximately 347 meters to corner 2, at or near Lat. 38° 6' 46.5" N., Long. 75° 14' 48.8" W., then running 26° 28' (True), approximately 456 meters to corner 3, at or near Lat. 38° 6' 59.7" N., Long. 75° 14' 40.4" W., then running 116° 11' (True), approximately 347 meters to corner 4, at or near Lat. 38° 6' 54.7" N., Long. 75° 14' 27.6" W., then running 207° 39' (True), approximately 436 meters to the point of beginning.


The applicants proposes to deploy lantern net style containers measuring approximately 2' diameter x 4' tall, that are suspended in mid-water from rows of anchored longlines, and each marked with a floating buoy, for the purpose of culturing Bay Scallop (Argopecten irradians) and Eastern Oyster (Crassostrea virginica). Harvest will conform to methods approved by the Department. The Department will hold a public informational meeting upon written request from a member of the public. In addition, any person who has a specific right, duty, privilege, or interest that is different from that held by the general public and may be adversely affected by the proposed lease may file a Petition of Protest with the Department. Petitions that meet the requirements of Natural Resources Article §4-11A-09(g) shall be forwarded to the Office of Administrative Hearings for adjudication.
