## Public Notice Maryland Department of Natural Resources Fishing and Boating Services Application for Shellfish Aquaculture Lease – Rachel A. Dean & Dale S. Dean #533, Calvert County

The Secretary of Maryland Department of Natural Resources (DNR), pursuant to Natural Resources Article, §4-11A-09(g), Annotated Code of Maryland, is giving notice of an application for a shellfish aquaculture water column lease by Rachel A. Dean and Dale S. Dean in the Patuxent River, Calvert County, Maryland, located approximately 1,400 feet southeast of the Gov. Thomas Johnson Memorial Bridge and 3,800 feet northwest of Sandy Point, on Solomons Island. The area applied for contains 2.7 acres more or less and is enclosed by a line beginning at corner 1, at or near Lat. 38° 19' 27.6" N., Long. 76° 27' 50.7" W., then running 310° 47' (True), approximately 179 meters to corner 2, at or near Lat. 38° 19' 31.3" N., Long. 76° 27' 56.4" W., then running 67° 54' (True), approximately 67 meters to corner 3, at or near Lat. 38° 19' 32.2" N., Long. 76° 27' 53.8" W., then running 121° 25' (True), approximately 137 meters to corner 4, at or near Lat. 38° 19' 29.8" N., Long. 76° 27' 49" W., then running 211° 31' (True), approximately 81 meters to the point of beginning.

The applicants propose to place cages on bottom up to a maximum of 18 inches high for the purpose of culturing Eastern Oyster (*Crassostrea virginica*), and to harvest using methods approved by the Department. The Department will hold a public informational meeting upon written request from a member of the public. In addition, any person who has a specific right, duty, privilege, or interest that is different from that held by the general public and may be adversely affected by the proposed lease may file a Petition of Protest with the Department. Petitions that meet the requirements of Natural Resources Article §4-11A-09(g) shall be forwarded to the Office of Administrative Hearings for adjudication.
