# 2024 MARYLAND LAND TRUST DIRECTORY

**Maryland's local land trusts operate in communities around the state.** Local service areas range from a single town or watershed to multiple counties and geographic regions. <u>Maryland</u> <u>Environmental Trust</u> (MET) partners with local land trusts to meet our mutual land conservation and stewardship goals.

In addition to partnering with local land trusts, MET will sometimes partner with other governmental entities or larger regional or national land trusts. These larger organizations may offer additional assistance and support to protect Maryland's most treasured landscapes and natural resources.

The Directory below lists MET's land trusts and conservation partners who co-hold conservation easements, have an executed and current <u>Cooperative Agreement</u>, or are actively working on conservation projects with MET.
